Stefnir hf. (Stefnir Asset Management Company) is an independent financial company according to Act No. 161/2002 on Financial Undertakings. The company operates on the basis of an operating license from the Financial Supervisory Authority of the Central Bank of Iceland as a manager of UCITS pursuant to Act No. 116/2021 on Undertakings for Collective Investment in Transferable Securities (UCITS) and as an alternative investment fund manager pursuant to Act No. 45/2020 on Alternative Investment Fund Managers. The company's operating license also applies to asset management, investment advice, and the custody and management of unit shares or shares in funds for collective investment. Stefnir is a subsidiary of Arion Bank.

## What is this product?

### Type

The fund is an alternative investment fund marketed towards the public pursuant to the Alternative Investment fund Managers Act No. 45/2020. Alternative investment funds marketed towards the public have broader investment authorisations than UCITS. The fund's investment authorisations are specified in the section on investment strategy in its prospectus.

### Name

Stefnir - Liquidity Fund (AIF)

### Objectives

The fund's objective is to invest in deposits, bills, bonds, and other short-term financial instruments. The aim is for the fund's portfolio to have an average duration of no longer than 180 days. There are no restrictions on the maturity of financial instruments issued by the Icelandic government or with its guarantee, as well as on covered bond issues by financial institutions. Individual investments in the fund are intended to have a maturity of no longer than 397 days from the time of investment. The fund management is based on tactical asset allocation with frequent adjustments to the asset composition.

The fund operates according to a predetermined investment strategy and will direct its investments towards opportunities that, in the opinion of the manager, are most likely to yield the best returns.

The fund is authorised to invest at its discretion in deposits of financial institutions (40-100%), bills, bonds, and other debt instruments issued by financial institutions (0-50%), bills, bonds, and other debt instruments issued by or guaranteed by the Icelandic government (0-60%), and bonds and other debt certificates issued by municipalities (0-30%).

The fund's returns depend on the increase or decrease in the market value of the fund's assets during the investment period, i.e., the period during which you hold units in the fund. Investors should understand that the fund's value can decrease as well as increase, and they must be able to withstand price fluctuations. The fund is well-suited for those looking to invest for the shorter term, ideally one month or more.

### Intended retail investor

The fund is suitable for both individuals and companies who wish to invest for the short term. The fund is designed for both the general public and institutional investors, such as pension funds and companies, who wish to choose an investment option involving funds for collective investments operated and managed by professionals and in accordance with current legislation and supervision of such funds.

### Term

The fund is an open-ended fund and has no maturity date. However, the manufacturer has the right to close the fund under certain circumstances, such as if the manufacturer deems it more favorable for the shareholders to close the fund or merge it with another fund. More information can be found in Article 8, Appendix I of the fund's prospectus. It is possible to purchase and redeem unit certificates in the fund on all regular business days under normal circumstances, with transactions prices based on the end of the business day. Orders received before the cut off time at 14:30 are settled after one business day. Orders received after the cut off time are settled after two business days. In exceptional cases, redemptions may be delayed.

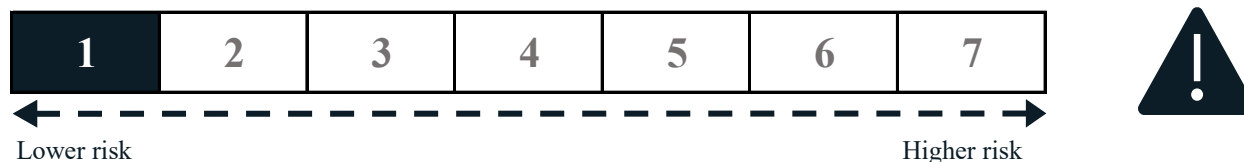
The fund was established on 3 April 2012.

# What are the risks and what could I get in return?

## Risk indicator



**The risk indicator assumes you keep the product for 1 month. The actual risk can vary significantly if you cash in at an early stage and you may get back less.**

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 1 out of 7, which is the lowest risk class.

This rates the potential losses from future performance at a very low level, and poor market conditions are very unlikely to impact our capacity to pay you.

Risk factors affecting the product that are not covered by the risk indicator include counterparty risk, operational risk, and liquidity risk. Other risk factors may also be present. This product does not provide protection against future market performance, so you could lose your entire investment.

**Counterparty risk:** The risk of loss to the fund due to the counterparty failing to meet its obligations before the final settlement of the fund's transactions occurs.

**Operational risk:** The risk of loss to the fund due to inadequate internal processes and errors related to human resources and systems of the management company, or due to external events, including legal and political risks, and risks associated with trading, brokerage, settlement, and valuation procedures carried out on behalf of the fund.

**Liquidity risk:** The risk that it may not be possible to sell, redeem, or close a position in the fund's portfolio at limited cost and within an acceptable timeframe.
